- From Malpensa Airport: train "Malpensa Express" to Milano Cadorna; from Cadorna F.N. station, train to Milano Domodossola (1 stop); Federchimica is at two minutes walking distance from Milano Domodossola (map).
- From Linate Airport: Bus to Railway Station "Milano Centrale"; from the Railway Station Milano Centrale": Metro Line n.2 (green line) to Railway Station "Cadorna F.N."; from Cadorna F.N. station, train to Milano Domodossola (1 stop); Federchimica is at two minutes walking distance from Milano Domodossola (please see the map).
